The American Board of Periodontology was organized by the American Academy of Periodontology in 1939 to elevate the standards and advance the science and art of periodontology by encouraging its study and advancing its practice. The Board serves the public and the profession by creating and administering a certification process to identify experts in the field of periodontics. The American Board of Periodontology is one of nine specialty boards recognized by the American Dental Association. The activities of the American Board of Periodontology conform to the "Requirements for Recognition of Dental Specialties and National Certifying Boards for Dental Specialists" of the American Dental Association Council on Dental Education applicable to specialty boards in dentistry. Dr. Hokett is a 1983 graduate of the University of Texas Health Science Center Dental School at San Antonio where he received a D. D. S. degree. He received a certificate in Periodontics at Fort Gordon, Georgia in conjunction with the Medical College of Georgia in 1991. He holds the U.S. Army Surgeon General's "A" Proficiency Designator and served as the Assistant Director and Director of the U.S. Army Periodontic Residency at Fort Gordon, Georgia from 1997 – 2003 whereupon he retired from active duty in the U.S. Army Dental Corps after twenty years of service. He has been a Diplomate of the American Board of Periodontology since 1994 and has authored or co-authored over twenty articles in peer-reviewed journals. Dr. Hokett earned the Masters of Clinical Research from OHSU School of Medicine in 2009. He is currently in the private practice of Periodontics at Salmon Creek Oral Surgery & Periodontics located in Vancouver, Washington and is also an Assistant Professor in the Department of Periodontology at the Oregon Health and Sciences University School of Dentistry.
